Fueron testigos de este acto los Senores: Antonio Franco G y Enrique Garay, mayores de edad y de esta vecinidad, quienes de conformidad, firmaron conmigo el Juez: Doy fe. - Carlos Garay. - Antonio Franco G. - Enrique Garay. - Rubrico. - Es copia fiel y correcto de su original. Doy fe Carlos Garay

[In the margin] Child Ana Maria Rodela. Act No. 165 one hundred and sixty-five = In Villaldama, N. Leon, on the 19 nineteenth day of the month of July of 1929 nineteen hundred and twenty-nine. Before me, Carlos Garay, Judge of the Civil State of this place, appeared at 10 hours [10:00 am], Senior Benito Rodela widow, 45 forty-five years old, laborer and resident and he gave evidence from the Mayor of this City, showing that the cited Senior has suffered the Corresponding Punishment, for infringement of Article 68 of the Civil Code of this State, not having registered within the required time, his daughter Ana Maria, who was born at the Hacienda de El Potrero of this jurisdiction on the 4 fourth of November of 1911 nineteen hundred and eleven, at 20 twenty hours [8:00 pm], the 3rd third legitimate daughter of the respondent and his wife Viviana Pena, deceased. Paternal grandparents - Andres Rodela and Agapita Salinas and maternal: Prajedis Pena and Paula Guerrero, the last three deceased. Witnesses of this act were the Senores: Antonio Franco G. and Enrique Garay, mature of age and from this vicinity, and agreeing, signed with me the Judge: I attest. - Carlos Garay. - Antonio Franco G. - Enrique Garay. - As directed. - This is a true and correct copy of the original. I attest. Carlos Garay.
