

**Andres RODELA PENA** December 21, 1903 - October 02, 1906

**Birth record from January 03, 1904:**

Al margen Andres Rodela = Acta numero 2 dos En Villaldama a los 3 tres dias del mes de Enero de 1904 mil novecientos cuatro. Ante mi Jose Ma Delfino Santos Juez del Estado Civil de esta Villa constituido en esta oficina a las 10 diez de la manana Se presente el C Gorge Gomez casado y vecino de esta y me presento un nino vivo que nacio el 21 veintiuno de Diciembre - ultimo a las 8 ocho de la manana y lleva por nombre Andres y hijo lejítimo del C Benito Rodela y de su esposa Viviana Pena originarios de la Hna del potrero de esta Sudiridicion Son abuelos del nino paternos el C Andres Rodela y Agapita Salinas y Maternos Prajediz Pena y finada Paula Guerrero del mismo origen y vecinidad: fueron testigos de esta acta los CC Jose Ma Santos y Florentino Trevino Solteros empleados y mayor de edad y vecinos de esta quienes conformes con la presente acta firmaron con migo el Juez Doy fe = Jose Ma Delfino Santos = Jose Ma Santos Gonzalez = Florentino Trevino = Rubricas = Es copia de su original = Doy fe = Jose Ma Delfino Santos

In the margin Andres Rodela = Act number 2 two in Villaldama on the 3 third day of the month of January 1904 nineteen hundred and four. Before me, Jose Maria Delfino Santos, Judge of the Civil State of this Villa established in this office, at 10 ten in the morning is present the Citizen Gorge Gomez, married and resident of this [villa], and introduced me to a live male child born on 21 twenty-one December last [year] at 8 eight in the morning and is named Andres, legitimate son of Citizen Benito Rodela and of his wife Viviana Pena native of the Hacienda del potrero of this jurisdiction. Paternal grandparents of the child are Citizen Andres Rodela and Agapita Salinas, and maternal are Prajediz Pena and deceased Paula Guerrero of the same origin and vicinity: witnesses of this act were the Citizens Jose Maria Santos and Florentino Trevino, single, employed and mature of age, residents of this [villa] who comply with this act signed with me, the Judge. I attest = Jose Maria Delfino Santos = Jose Maria Santos Gonzalez = Florentino Trevino = As directed = This is a copy of the original = I attest = Jose Maria Delfino Santos.

**Baptismal record from March 03, 1904:**

[Al margen] No. 57 Andres nacio el 8 de Octubre en el Potrero. En la Iglesia parroquial de Villaldama, a tres de Marzo de mil novecientos cuatro, el infrascrito cura interino bautize solemnemente dando el nombre de Andres, a un nino nacido el dia ocho de Octubre del ano proximo pasado, hijo legitimo de Benito Rodela y Bibiana Pena. Padrinos fueron Andres Alvarado e' Ygnacia Gonzalez, a quienes adverti su obligacion y parentesco espiritual. Doy fe. Jose C. Venegas

[In the margin] No. 57 Andres was born on 08 of October at el Potrero. In the parish church of Villaldama, on the third of March nineteen hundred and four, the undersigned interim priest solemnly baptized giving the name of Andres to a male child born 08 of October of last year, legitimate son of Benito Rodela and Bibiana Pena. Godparents were Andres Alvarado and Ygnacia Gonzalez, whom I advised of their obligation and spiritual kinship. I attest. Jose C. Venegas.

**Confirmation record from March 21-23, 1904:**

Confirmaciones hechas por el Ultmo. Y Revino. Sr. D. Santiago Garza Zambrano, Arzobispo de esta Diocesis en su transito por esta de la Parroquia de Sabinas Hidalgo en donde acababa de practicar la Santa Pastoral Visita, los dias veintiuno, veintidos y veintitres de Marzo de ano de 1904.

Villaldama 23 de Marzo de 1904. Jose C. Venegas. [Note next entry] Villaldama, Sep. 17 de 1906. Por orden Superior tome posesion del presente Libro hoy dia de la fecha. --- Teodoro F. Pulido

[Begin 1904, image 206] Confirmations made by the current and Reverend Esq. Santiago Garza Zambrano, Archbishop of this Diocese in his transit through the Parish of Sabinas Hidalgo where he just made a Holy Pastoral Visit, on the twenty-first, twenty-second and twenty-third of March of the year 1904.

[End 1904, image 226] Villaldama, 23 March 1904. Jose C. Venegas. [Note next entry] Villaldama, Sep. 17, 1906. Per Superior order, I take possession of this Book on today's date. --- Teodoro F. Pulido.

**Death record from October 03, 1906:**

Al Margen = Parvolo Andres Rodela = centro = Acta numero 133, ciento treinta y tres. En Villaldama a los 3 tres dias del mes de Octubre del 1906 mil novecientos seis. Yo Jose Ma. Delfino Santos juez del Estado Civil de esta Villa hago contar que hoy a las 8, ocho de la manana comparecio en esta oficina el C. Doroteo Ruis soltero mismo que crio de esta y dijo: que ayer a las 2 dos de la tarde fallecio en la hacienda del Potrero de esta jurisdiccion el nino Andres Rodela a la edad de 4 cuatro anos hijo legitimo del C Benito Rodela y Viviana Pena originarios y viene de dicho hacienda: por el certificado del Dr. Celso J Villarreal cuenta que el nino fallecio de tuberculosis. Le mande dar sepultura conforme a la ley en el panteon de esta en fosa comun: fueron testigos de este acto el presentante y el C Jose Ma. Santos soltero empleado y vecino de esta firma Santos y no Ruis pa no saber conmigo el juez doy fe = Jose Ma. Delfino Santos = Jose Ma. Stos Gons = rubrica = Es copia sacada de su original. Doy fe = Jose Ma Delfino Santos.

In the margin = Infant Andres Rodela = center = Act number 133 one hundred thirty three. In Villaldama on the 3 third day of the month of October of 1906 nineteen hundred and six. I, Jose Maria Delfino Santos, judge of the Civil State of this Villa, I note that today at 8, eight in the morning appeared in this office the Citizen Doroteo Ruis, single, raised in this [villa] who said: that yesterday at 2 two in the afternoon, died at the hacienda del Potrero of this jurisdiction, the male child Andres Rodela at the age of 4, four years legitimate son of Citizen Benito Rodela and Viviana Pena, natives and residents of said hacienda: per the certification of Dr. Celso J Villarreal, states that the child died of tuberculosis. He is sent to be buried according to the law at the cemetery in this (villa) in a communal grave: witnesses of this act were the presenter and the Citizen Jose Maria Santos, single, employed and resident of this [villa]. Signed by Santos but not Ruis who is unknown to me, the judge. I attest = Jose Maria Delfino Santos = Jose Maria Santos Gonsales = As directed, this is a copy of the original. I attest = Jose Maria Delfino Santos.
