[In the margin] Child Rodolfo Duran. Act No. 110 one hundred ten - En Villaldama, N. Leon, on the 14 fourteenth day of the month of May of 1929 nineteen hundred and twenty-nine. Before me, Carlos Garay, Judge of the Civil State of this place, appeared to me at 10 ten hours [10 am], Senior Felix Covarrubias, married, chauffer, 31 thirty-one years of age, originally from and resident of the Hacienda "El Potrero" of this jurisdiction, and presented for registration a live male child, who was born on the 30 thirtieth of April last, at 21 twenty-one hours [9 pm], at the Potrero and he was named Rodolfo, 2nd

legitimate son of Senor Vicente Duran, married, 25 twenty-five years of age, laborer and resident of the Potrero, and of his wife Carmen Rodela, 20 twenty years of age and from the same vicinity. Paternal grandparents are: Jesus Duran and Plutarca Vazquez, and maternal: Benito Rodela and Viviana Pena. Witnesses of this act were Senores: Antonio Franco G and Enrique Garay, mature of age and of this vicinity, who agree, sign with me the Judge: I attest. - Carlos Garay. - Antonio Franco G. - Enrique Garay. - As directed. - This is a true and correct copy of the original. I attest, Carlos Garay.
