[In the margin] Maria Rodela. Act number 4 four. In Villaldama, Nuevo Leon, on the 1st first of January of 1919 nineteen hundred and nineteen. Before me, Miguel Villarreal, Judge of the Civil State of this Villa, established in this court at 8 eight in the morning appeared Senor Benito Rodela, married, 30 years of age, laborer, originally from and resident of the Hacienda del Potrero of this municipality, and he presented a live female child who was born on the 8 eight day of September at 6 six in the morning of the year 1918 nineteen hundred and eighteen, named Maria Rodela eighth legitimate child of the presenter and of his wife Viviana Pena 30 years of age. Paternal grandparents are Andres Rodela and Agapita Salinas, deceased, and maternal Prajades Pena and Pabla Guerrero, deceased. Witnesses were Norberto Cisneros and Gabriel Gonzales, the first married and [second] single, employed, mature of age and residents of this [villa]. They signed with me, the Judge. I attest = Miguel Villarreal = Norberto Cisneros = Gabriel Gonzales = As directed = This is a copy of the original = I attest, Miguel Villarreal.

Legitimate daughter of Benito Rodela and Bibiana Pena. Paternal grandparents: Andres and Agapita Salinas. Maternal grandparents: Prajedis and Paula Guerrero. Witnesses were: Catarino Botello and Victoria Albarado, whom I advised of their obligation and spiritual kinship. For the record, I sign. F. Victor Garza
